PERSONAL DATA AGREEMENT FOR MEMBERS/VOLUNTEERS

For the purposes of member/volunteer registration, the Cyprus Red Cross Society (hereinafter referred to as "CRCS") collects and processes personal data concerning applicants. The CRCS undertakes to be transparent with regard to the collection, handling and maintenance of applicants' personal data, in accordance with the CRCS's data protection obligations.

1. TYPE OF PERSONAL DATA COLLECTED

The CRCS collects a range of information about you (see "Membership/Volunteer Application Form"). This includes, without limitation, the following:

- your full name, residential address and contact information, including phone number
- details of the qualifications, experience and type of assistance you can provide,

The data will be stored securely in the CRCS archive, which is securely kept at our premises, with access limited to the HR officer(s), Management as well as the individual Director of the CRCS.

2. PURPOSE OF DATA COLLECTION

The principles and purposes of the CRCS are governed by the Cyprus Red Cross Law 39 of 1967 and the CRCS Regulations adopted on 25/01/2012. CRCS requests your consent for the processing of personal data during the member/volunteer registration process and for maintaining the personal data in our records. The processing of applicant personal data allows us to manage the process of registering members/volunteers, as well as to evaluate and confirm the eligibility of a prospective member/volunteer for registration.

The data of the successful applicants will be processed and maintained for the duration of successful applicants' CRCS subscription, as well as after the expiration of their subscription for a further 7 years for archiving purposes and facilitating their re-registration during this period. After 7 years their personal data will be deleted, and only non-identifiable data will remain for statistical purposes. If your application is unsuccessful, the CRCS will not retain the Membership/Volunteer Application Form and/or any other data unless specifically requested. If you request that your information be retained by the CRCS, you should also note that you are free to withdraw your consent at any time.



DECLARATION BY PROSPECTIVE MEMBER/VOLUNTEER

I freely grant the Cyprus Red Cross Society my consent to use and process my personal data regarding my membership/volunteer application for the purposes explained above. By giving my consent, I fully acknowledge and understand all of the foregoing terms.
